ANY ITEMS DEEMED UNUSABLE OR HIGHLY DAMAGED WILL NOT BE CONSIGNED

CONSIGNOR SHALL INDEMNIFY, RELEASE, DEFEND, AND HOLDS HARMLESS FOREVER Re-Ride LLC, its officers, directors, Shareholders, employees, successors and assigns from any and all claims and liabilities, of whatsoever kind (Including but not limited to attorneys' fees), arising from or connected to the consigned goods. Re-Ride LLC shall use all Conventional safeguards in the handling and displaying of consigned goods but has no legal responsibility for items Left on consignment or taken on trial.

CONSIGNMENT PROCEDURES:

1. Consignments will be accepted by appointment only.
2. Consignor must provide a signed detailed list of all items being consigned for our records.
3. Consignor must sign a new contract for each individual Drop Off.
4. Re-Ride LLC shall determine pricing on all consigned items and reserves the right to lower the price as needed.
5. ANY ITEMS BROUGHT IN DIRTY, OR THAT ARE LISTED ON THE NON-CONSIGN-ABLE ITEM LIST WILL NOT BE CONSIGNED.

CONTRACT RESPONSIBILITY:

1. Items can only be removed from consignment by scheduling an appointment for pick up.
2. AFTER 1 YEAR IN INVENTORY, ALL ITEMS NOT SOLD BECOME PROPERTY OF RE-RIDE LLC AND ARE CONSIDERED A DONATION. NO PAYOUTS OR STORE CREDIT WILL BE GIVEN FOR ANY SALE OF ITEMS AFTER EXPIRATION DATE.
3. Re-Ride Store Credit for the sale of consigned items expires fourteen (14) months after the date posted.
4. It is the CONSIGNORS sole responsibility to keep track of the items they have consigned including date of expiration for the items and/or store credits for items sold.
5. Re-Ride LLC CANNOT be held responsible for damages, loss, or theft of items left on consignment, but does agree to use ALL conventional safeguards in the handling and displaying of consigned goods. Items may be covered under your Homeowner's Policy.
6. This contract is non-transferable and is between one Consignor ONLY & Re-Ride LLC.
7. CONSIGNOR MUST BE 18 or older!

PAYMENT TO CONSIGNOR AGREEMENT AND SCHEDULE:

CONSIGNMENT PAYMENT SPLIT: 65/35 ON SADDLES & 50/50 ON ALL OTHER ITEMS.

1. It is not the responsibility of Re-Ride LLC to contact you when your item sells. Consignor must call or email to inquire about the status of your items and/or store credits.
2. PAYMENTS TO CONSIGNORS ARE MADE ON A CASH FLOW BASIS and there is no set date for your check to arrive. You may use your store credit at any time for which you will receive an additional 15% off your purchase.
3. You must request a payout via text/website/or in person to be added to the payout list. Consigner will not be automatically added to payout list, or contacted when your items sell.
4. Payouts are not available on demand . You will not receive a payout immediately if you come in person or inquire about your items. We will only add you to the payout list upon inquiry in person or via phone/email.
5. Payouts are made in the order requests for payouts are received.
6. PAYOUTS TO CONSIGNORS WILL START ON THE 15TH OF THE FOLLOWING MONTH OF SALE DATE in case of exchanges. This does not mean you will receive your payout on the 15th.
