

# Re-Ride LLC ~ Consignor Contract

***65/35 split of the selling price on Saddles... 50/50 on everything else.***

**ACCEPTABLE ITEMS:** Saddles, bridles, bits, harness, books, pictures, and any other equine related items in good & clean condition. Riding clothing including lightly used jackets, shirts, boots with zippers, chaps, etc.

Re-Ride shall determine the acceptability of an item and has the right to refuse or return any item deemed unable to sell, to the consignor. If items are dropped off, item may be discarded if unsafe. *Any item that is left at Re-Ride that needs cleaning/repairs will be considered a donation.*

## **PROCEDURE:**

1. Consignments will be accepted by chance or appointment.
2. Each consignor must sign a contract & will be given an identification number.
3. Re-Ride will price the item for what it is worth according to market standards, age, and condition.
4. If you have a certain price you would like to get on an item, we will attempt to get the price you desire. If an offer is made on your item, we will notify you and let you accept, counter offer, or refuse.

## **CONTRACT RESPONSIBILITY:**

1. Any item consigned that is removed by consignor before 6 months will be charged the commission of 50% (35% for saddles) using the price on tag, which is the same as if item had sold.
2. *After 2 year in inventory, all items not sold become the property of Re-Ride and considered a donation. So please, stop in and see us, give us a call, keep in touch. We are happy to renew the inventory date for you if you wish.*
3. Re-Ride cannot be held responsible for items left on consignment, but does agree to use all conventional safeguards in the handling and displaying of consigned goods. Items may be covered under your homeowner's policy. This contract is non-transferable and is between one consignor only & Re-Ride.

## **PAYMENT:**

1. Books will close on the last day of the month. Checks are issued on the 15th of the month for the previous month. We mail out checks once your balance reaches \$25.00 or more. Payments are made on a cash flow basis. WE DO NOT CALL WHEN ITEMS SELL, but give us a call and we will be happy to check for you.
2. Consignors may be paid for layaway (max 60 Days) items the month after the sale is completed.

## **PRICE REDUCTIONS:**

1. Re-Ride reserves the right to lower price of items to help move the item.
2. Re-Ride covers "Sales" portion of item. As a consignor, "sales & discounts" WILL NOT affect the amount you receive for an item on consignment. This is the reason for the 50/50 split.
